

## **UNSOLICITED PROPOSAL**

### **Under Rule 37(a) of PPRA Rules, 2004 (as amended upto date)**

Cantonment Board Clifton (CBC) being a procuring entity is committed to provide municipal services in its area of jurisdiction. In the frame-work of Solid Waste Management, CBC has received an unsolicited proposal for disposal of about 400 tons Solid Waste being generated in Cantonment Board Clifton area of responsibility which is initially being transported from all areas of Clifton Cantonment and dumped at Garbage Transfer Station (GTS) near Korangi road crossing Imtiaz Super Store chowk through Modern Solid Waste Management System using segregation / automatic sorting facility, composting, disposal of landfill waste at landfill site etc at their own cost for the period of 5 years extendable for further two (2) similar terms.

2. As per Rule 37-A of PPRA Rules, 2004 (as amended upto date), a proposal from companies / firms working in integrated waste management sector is hereby invited with the intent of providing waste free, upto the mark clean and hygienically purified and unpolluted environment for which the company / firm will be responsible for disposal of about 400 tons Solid Waste being generated in Cantonment Board Clifton area of responsibility which is initially being transported from all areas of Clifton Cantonment and dumped at Garbage Transfer Station (GTS) near Korangi road crossing Imtiaz Super Store chowk through Modern Solid Waste Management System using segregation / automatic sorting facility, composting, disposal of landfill waste at landfill site etc at their own cost for the period of 5 years extendable for further 5 years.
