CBC invites electronic bids for Supply and Fixing / Installation of Networking in Main CBC Office Building, Clifton Cantt in accordance with PPRA Rules 2004 (As amended upto date) from the eligible firms registered with Income Tax and Sales Tax Deptt and are on active tax payer's list of FBR and also registered with Cantonment Board Clifton being procuring entity for electronic bidding.

Major Terms and Conditions are as under:

1. The quotations / tenders should only be submitted electronically online, on or before 04 January, 2023 at 11:00 am through e-Tender portal of ML&C Deptt (<https://etender.mlc.gov.pk>) which will be opened on the same day electronically at 11:30 am. The contractors will be able to see comparative statement online.
2. The bidder shall submit 4% Bid Security of the estimated cost sealed in envelop in the shape of call deposit at (original) only through courier before closing date and time.
3. In case of bid/rate quoted by the bidder is more than 10% below the item rate, the additional bid security shall be sought from the successful bidder only to the extent of bid more that 10% below the estimate in the form of percentage. The amount of additional bid security shall be equal to the impact of financial difference occurring in the quoted rates beyond 10% below estimate.
4. Electronic bids should be submitted electronically on or before the fixed date / time.
5. The bidders can register themselves with Cantonment Board Clifton at etender.mlc.gov.pk for online bidding one day prior to the last date of submission of the electronic bids.
6. Electronic Bidding rates shall be quoted / evaluated on "Above / Below or at par" basis of Gross Amount Of BOQ. Only two digits after the decimal point shall be considered for evaluation purpose.

7. Who provides incorrect information shall stand disqualified and will be debarred under rule 19 of the PPRA Rules, 2004 (As amended).
8. Time allowed for completion of the work is as specified in the NIT which will start from the issuance of letter of acceptance.
9. Electronic Bids will be valid for 6 Months and rates shall be inclusive of FOR destination.
10. Successful Bidder shall sign the agreement with the procuring entity within Fifteen (15) days after acceptance of bid.
11. The quoted rates shall be inclusive of all applicable Government (Federal / Provincial) Taxes.
12. Call Deposit of scheduled Banks shall be acceptable from the respective Bank Account of the bidder.
13. At least 02 year experience of supply, fixing & maintenance of CCTV system in reputed firm/Deptt and also will have to produce completion certificate as well. The bidder/supplier shall conduct complete survey at the sites for the purpose of establishing Wireless Local Area Network in Head Office CBC & Supplier/contractor/firms shall supply, fix and make functional the wireless LAN with proper wiring and rack harnessing with tags within 20 Days, after issuing of work order, All equipment must be in warranty.
14. Any bid received in contravention of enabling provisions of PPRA rules, 2004 will be declared non responsive by the Board being procuring entity. Cantonment Board Clifton being procuring entity reserved the right to accept or reject any E-bid on technical / administrative grounds under Rule 33(1) of PPRA Rules, 2004 (As amended upto date).
