QUOTATION / TENDER NOTICE

CBC invites electronic bids for demolition of illegal building No. A-35/8 Dehli Colony No. 1, Katchi Abadi Clifton Cantt in compliance with the order dated 12-04-2021 passed by Honorable High Court of Sindh CP No. D-137 of 2019. The Building has an RCC structure comprising Ground + 9x stories (66 Sq Yard) on a lump sum basis, including disposal of debris in accordance with PPRA Rules 2014 (As amended upto date) from the eligible firms registered with Income Tax and Sales Tax Deptt and are on active tax payer's list of FBR being procuring entity for electronic bidding.

Major Terms and Conditions are as under:

1. The quotations / tenders should only be submitted electronically online, on or before 25 May, 2021 at 1200 pm through e-Tender portal of ML&C Deptt (<https://etender.mlc.gov.pk>) which will be opened on the same day electronically at 12:30 pm. The contractors will be able to see comparative statement online.
2. The bidder shall submit 2% Bid Security of the Engineering estimated cost sealed in envelop in the shape of call deposit at (original) only through courier before closing date and time.
3. In case of bid/rate quoted by the bidder is more than 10% below the item rate, the additional bid security shall be sought from the successful bidder only to the extent of bid more that 10% below the engineer estimate in the form of percentage. The amount of additional bid security shall be equal to the impact of financial difference occurring in the quoted rates beyond 10% below engineer estimate.
4. Electronic bids should be submitted electronically on or before the fixed date / time.
5. The bidders can register themselves with Cantonment Board Clifton at etender.mlc.gov.pk for online bidding one day prior to the last date of submission of the electronic bids.

6. Electronic Bidding rates shall be quoted / evaluated on "Lump Sum" basis of Gross Amount of BOQ. Only two digits after the decimal point shall be considered for evaluation purpose.
7. Who provides incorrect information shall stand disqualified and will be debarred under rule 19 of the PPRA Rules, 2004 (As amended).
8. Time allowed for completion of the work is as specified in the NIT which will start from the issuance of letter of acceptance.
9. Electronic Bids will be valid for 6 Months and rates shall be inclusive of FOR destination.
10. Successful Bidder shall sign the agreement with the procuring entity within Ten (10) days after acceptance of bid.
11. The quoted rates shall be inclusive of all applicable Government Taxes
12. Call Deposit of scheduled Banks shall be acceptable from the respective Bank Account of the bidder.
13. All safety measures for surrounding properties must be ensured.
14. The responsibility of any loss of properties & human lives shall lies upon the bidders.
15. The time of demolition is 30 days.
16. Debris shall be removed on a daily basis.
17. Other information shall be obtained from the CBC office on any working days.
18. Any bid received in contravention of enabling provisions of PPRA rules, 2004 will be declared non responsive by the Board being procuring entity. Cantonment Board Clifton being procuring entity reserved the right to accept or reject any E-bid on technical / administrative grounds under Rule 33(1) of PPRA Rules, 2004 (As amended upto date).
