- c) The successful bidder shall deposit one-fourth of the total bidding amount on the spot on drop of hammer, while the remaining amount shall be deposited, within three days of confirmation of the bid by the Board.
- d) The successful bidder shall pay Income Tax @ 10% and 17% GST in addition to the bid amount.
- e) Notice of the rejection of all bids or proposals shall be given promptly to the concerned participants.
- f) The auctioned material will be released/handed over to the highest bidder, subject to full payment of auction inclusive of all taxes i.e. GST @17% & withholding tax @10%.
- g) All those Parties /firms who have been black listed by any Govt. departments / in litigation with CBC shall not be allowed to participate in the Auction proceedings.
- h) Executive Officer/ Board may accept / Reject any or all bids or proposal at any time prior to the acceptance of a bid or proposal. Executive Officer/ Board shall upon request communicate to any auctioneer, who submitted a bid, the grounds for its rejection of all bids, but is not required to justify those grounds.
