

## TENDER NOTICE

The Sealed Tenders are invited from well-established firms/ supplier registered with CBC, GST/ Income Tax Department / for supply of the store items, as per PPRA Rules / and other terms and conditions as detail appended below:-

1. The interested Companies/Suppliers are required to submit their bids through **Single stage single envelope** procedure, as outlined in Rule No.36 (a) of PPRA Rule-2004.
2. All quotations / tenders should be properly enveloped, sealed and addressed to the undersigned with clear endorsement of tender reference on the right corner of envelop i.e. **“TENDER FOR SUPPLY OF STORES ITEMS”**.
3. The Store items shall be delivered on **“AS AND WHEN REQUIRED BASIS”** on requisition made by the Cantonment Executive Officer.
4. Tenders should be free from any sort of OMISSIONS / TEMPERING i.e. cutting, erasing, overwriting etc.
5. Validity of quoted rates must be for the financial year 2018-19, extendable to another one year.
6. Quoted rates shall be inclusive of all taxes, as admissible under the rules.
7. Quotations/tenders shall be accompanied with **earnest money of Rs.100000/-** (refundable) in the shape of pay order in favour of Executive Officer, Clifton Cantonment Board in original. The quotations/tenders without earnest money shall not be entertained.
8. The Tender Documents can be obtained from Office of Cantonment Board Clifton @ Rs.5000 ( non-refundable) on or before **25<sup>th</sup> July-2018**.
9. All those contractors who have been black listed by any Govt. departments / in litigation with CBC shall not be issued quotation / tenders documents.
10. Sealed quotations/tenders should reach to the undersigned, at the address of CANTONMENT BOARD CLIFTON.
