## INVITATION OF SEALED BIDS

Sealed bids for the auction of building material of RCC overhead water tank having capacity of 5000 gallon located at Kh-e-Bukhari Phage-VI DHA Karachi as same is declared dangerous by Consultant / Structure Engineer and Engineering staff of this office and in accordance with PPRA Rules 2004 (As amended upto date) on "AS IS WHERE IS" are invited from the interested parties / firms which should reach the office of the Cantonment Board Clifton on or before 30 May, 2022 at 11:00 hours and the bids will be publically opened on the same day at 11:30 hours in the presence of bidders and their representatives who may choose to be presence under rule 28 (2) of PPRA Rules, 2004 (as amended upto date).

### Terms & Conditions.

1. Interested bidders / persons/ firms registered with Sales Tax Department can participate in the bidding procure.
2. Interested parties / persons / firms shall deposit Rs. 1,50,000/- as earnest money in the form of pay orders in favour of Cantonment Board Clifton.
3. The bid will only be accepted after approval by the Board.
4. The highest bidder shall deposit one-fourth of the total bidding amount at the fall of hammer, while the remaining amount shall be deposited within 03 days of approval of the bid by the Board.
5. The highest bidder shall pay all applicable Govt Taxes as per prevailing rates in addition to the bid amount.
6. Bidders shall provide their CNIC, Office address and telephone / cell numbers, email/ fax number.
7. Notice of the rejection of all bids shall be given promptly to all auctioneer that submitted bids.
8. The auctioned material will be released / handed over to the highest bidder, subject to full payment of bid money inclusive of all Govt Taxes.
9. Cantonment Board Clifton may reject any or all bids or proposal at any time prior to the acceptance of a bid or proposal. Cantonment Board Clifton shall upon request communicate to any auctioneer who submitted a bid, the grounds for its rejection of all bids, but is not required to justify those grounds.

10. The office of Cantonments Board Clifton can be visited for information on the subject during office hours.
11. The Advertisement is also available on PPRA website.
12. All safety measures for surrounding properties must be ensured.
13. The responsibility of any loss of properties and human lives shall lie upon the successful bidder.
14. The time of demolition and removal of material along with debris is 30 days.
15. Demolition material along with debris shall be removed on a daily basis.
16. Any bid received in contravention of enabling provision of PPRA Rules, 2004 (as amended up to date) will be declared non-responsive by the Board being the procuring entity. Cantonment Board Clifton being the procuring entity reserves the right to accept or reject any bid on technical/administrative ground under the Rule 33 (1) of PPRA Rules, 2004 (as amended up to date).
